Description

The CPC1035N is a miniature single-pole, normally open (1-Form-A) solid state relay in a 4-pin SOP package that employs optically coupled MOSFET technology to provide 1500V_{rms} of input to output isolation. The efficient MOSFET switches and photovoltaic die use IXYS Integrated Circuits Division's patented OptoMOS architecture while the optically coupled output is controlled by a highly efficient GaAlAs infrared LED.

IXYS Integrated Circuits Division's state of the art double-molded vertical construction packaging makes the CPC1035N one of the world's smallest relays. It offers board space savings of at least 20% over the competitor's larger 4-pin SOP relay.






Typical Blocking Voltage Distribution (T_A=25°C)



Typical Turn-Off










Board Wash


IXYS Integrated Circuits Division recommends the use of no-clean flux formulations. However, board washing to remove flux residue is acceptable. Since IXYS Integrated Circuits Division employs the use of silicone coating as an optical waveguide in many of its optically isolated products, the use of a short drying bake could be necessary if a wash is used after solder reflow processes. Chlorine- or Fluorine-based solvents or fluxes should not be used. Cleaning methods that employ ultrasonic energy should not be used.




